Pathways to Property Review 2016



Project background

Launched in 2012, Pathways to Property aims to widen access to the real estate profession by raising awareness of, and aspirations about, the vast range of careers available within the property and real estate sector.

Pathways to Property is led by the Reading Real Estate Foundation and was established as a response to the recognised lack of diversity in the industry. Its successes are due to the very strong industry support which it enjoys. Amongst all but a minority of schools, there is a general lack of awareness and understanding of the industry and the vast and varied career opportunities available within real estate and the wider property sector. Able students from less advantaged and non-traditional families are not being exposed to these opportunities. By engaging with sixth form students, their teachers and careers advisers, Pathways to Property works to introduce the idea of real estate as a subject of study and to provide a way for young people to find out about careers within the property sector.

The aims of the project are:

- To increase the diversity of applications to the University of Reading Real Estate and Planning degrees by promoting the attractions of a career in the property industry to students from state schools, focussing on an annual Summer School. Priority at the Summer School will be given to academically able students from disadvantaged and non-traditional backgrounds.
- To encourage interest in a property career amongst talented students from all backgrounds by increasing the effectiveness of communications between the industry and students.





Now in its fifth year, Pathways to Property will see the first of its Summer School students graduate in July 2017.

RREF is a unique and forward-thinking educational charity, established to support real estate and planning education at the University of Reading. As well as supporting Pathways to Property, RREF engages with and supports students to help them achieve their full potential and become the best in the industry. This is done through financial support, a mentoring programme, an annual careers fair and an evening lecture series. RREF continues to engage and connect with students as they become alumni, through fundraising and networking events that help to support the aims of the charity.

In 2015–2016, RREF:

- Awarded £182,663 to 65 students through bursaries, scholarships, hardship grants, PhD studentships, prizes and awards.
- Enabled 306 students to be mentored by 235 industry mentors.
- Had representatives from 35 firms at the annual careers fair with 323 students attending.

Pathways to Property 2015–2016

The project's key objectives for 2015–2016 included:

Delivering an inspiring outreach programme

During its fourth year, Pathways to Property continued to raise awareness of real estate as a subject of study and a career path to young people from non-traditional and disadvantaged backgrounds. The project attended over 40 different events during 2015–16 and engaged with young people, teachers and careers advisers.

During 2015–16, Pathways to Property:



Extending and creating further external partnerships and volunteer connections

During 2015–16, the collaboration with Property Needs You continued to be strong, and saw a very effective presence at a number of large events, including Skills London, the National Careers Guidance Shows and a careers advisers' conference. The project has also worked with a number of social mobility organisations and careers advice services to reach larger numbers of young people with information about careers within property as well as the activities offered by Pathways to Property.

It is only through the support of individuals and firms volunteering their time that Pathways to Property is able to achieve what it does. Whether it is giving a talk in a school, supporting the Summer School, or hosting a work experience placement, the time donated by volunteers and firms is key to the success of the project.

Continuing to develop relationships with schools outside the South East

A long-term aim of Pathways to Property is to continue to widen the geographical reach of the project. The National Careers Guidance Shows and, this year, the careers advisers' conference are effective ways of reaching a wider audience. The project also worked with other organisations to promote Pathways to Property and the Summer School as widely as possible, with the result being an increase in attendees from the North East, Yorkshire and the West Midlands.

Evaluating what the project has achieved to date and looking to the future

With three successful years completed and 2015–16 being the fourth year of the project, Pathways to Property has been looking to the future and exploring how we build on the momentum and achievements of the project. The Project Board has been exploring new and innovative ways to engage with young people, teachers and careers advisers and to ensure the aims of the project continue to be met. One key activity undertaken over the course of the year has been a research project exploring how early-career property professionals found their way into the industry. The results of this research were published in *Property Week* and are being used to inform the strategy of Pathways to Property going forwards.

Tracking students through their interactions with the project

With the passing of each year, increasing numbers of students have interacted with the project and Pathways to Property is putting in place processes to try and increase our ability to track the students we have engaged with. Currently, we contact students the summer they are due to have finished sixth form to find out their plans but, with the first cohort of Pathways to Property Summer School students graduating in July 2017, we will be contacting these students again to try and find out where their careers are taking them.





Pathways to Property Summer School 2016

The highly successful Pathways to Property Summer School took place once again at the University of Reading from 25th–28th July 2016. With 93 year 12 students eager to learn more about property and to experience university life, the fourth Summer School delivered a full programme of academic and social activities.

The programme used different media to facilitate discussions around current themes in property, whilst also raising awareness of the many and varied roles and career opportunities within the sector. One of the highlights for the students was working on their group project; a stakeholder debate about a proposed housing development on the edge of Reading, which saw the students presenting to a group of invited guests on the final day. The debate that ensued was enthusiastic, passionate and heated.

We are incredibly grateful for the support given by so many to enable the Summer School to be the success it is. Thanks must be given for the extensive support provided by the industry and by the academics from the School of Real Estate and Planning at the University of Reading. This support was multi-faceted and included delivering lectures and academic sessions, supporting the students as they worked on their group projects, hosting site visits for the students, and attending the presentations and talking with the students on the final day.

Pathways to Property 2016–2017

The project's key objectives for 2016–17 include:

Increase the number of students moving from the Summer School to relevant courses

Three of the four cohorts of Pathways to Property Summer School students are now of university age and, as the figures earlier in this Review demonstrate, a significant number are studying at university and a sizeable number are studying or working within the property sector. Pathways to Property will continue to explore ways to encourage an interest in property and to support the Summer School students to progress to relevant courses.

Increase bursary levels to support the most disadvantaged

Research shows that financial concerns can be a major barrier to students from disadvantaged and non-traditional backgrounds in accessing higher education. Pathways to Property continues to offer the £1000 welcome bursary to all Summer School attendees who enrol on a real estate and planning course at the University of Reading, and the level of bursary support students can apply for will increase.

Extend outreach beyond the Summer School

The Pathways to Property Summer School is now a well-established and very successful annual event in the project's calendar, with the fifth Summer School due to take place at the end of July 2017. Building on the success of this activity, the project is keen to engage with more young people, including those who, for whatever reason, are unable to attend the Summer School. The Project Board is exploring creative ways in which to reach different audiences as well as possibly extending the breadth of the project to include some engagement with younger students.

Share our experience and knowledge with other institutions

Pathways to Property made some initial approaches to other institutions offering real estate courses in its earlier years, and the project is now seeking ways to explore further the possibilities of sharing knowledge and experience with other institutions.

We are always looking to engage with more individuals and firms to support this innovative project through both financial and non-financial support. For Pathways to Property to have an effect on actual numbers of graduates entering the industry, we need to not only maintain the current momentum, but to keep seeking ways for the project to grow and the level of activity to increase. Financial support

Work placements

During every October half-term, we offer students who attended the Summer School the chance to apply for a week-long work experience placement. The placements provide an incredibly valuable insight into the sector for the students as well as giving them experience working in a corporate environment.

We are always looking for firms across the UK who would be willing to host a student for the week. Pathways to Property offers all students taking part in a work experience placement a £200 bursary to cover transport and other costs. Firms are not asked to contribute towards this.



Volunteering

We welcome volunteers from across England and Wales to help deliver the project. This could be by volunteering to support the students at the Summer School or by giving talks in state schools and colleges. The aim of the talks is to raise the profile of the property industry to Year 12 students (16–17 year olds), teachers, careers advisers and parents as well as promoting the Pathways to Property Summer School.

Talks often take place during assemblies, but could also be in a lesson such as geography, economics or business studies. We suggest volunteers talk about their experiences and why they enjoy working in the sector in order to inspire students and promote real estate as a career.
